#### 1. Important topics

### ARIPO: 3rd edition of the Heads of Intellectual Property Offices Conference (HIPOC)<sup>1, 2, 3, 4</sup>

The 3<sup>rd</sup> edition of the Heads of Intellectual Property Offices Conference (HIPOC) was held on 6-8 June 2024 in Praia, Cape Verde. The conference, with the theme "Leading Towards a Thriving African Intellectual Property Ecosystem" was attended by 22 Heads of IP Office from the ARIPO member states. The aim was to promote the exchange of experiences on the administration and management of intellectual property rights in the region, strengthening cooperation among member countries towards sustainable development.

# ARIPO: WIPO - ARIPO Meeting on the Development of a Regional Technology & Innovation Support Center (TISC) Network<sup>5</sup>

Jointly organized by WIPO, supported by the Japanese Patent Office (JPO), this meeting was held at the ARIPO Secretariat on 6 June 2024. The TISCs activity supports ARIPO with technologies to support innovation.

#### ARIPO: ARIPO - CNIPA launch Patent Prosecution Highway Pilot Program<sup>6</sup>

A bilateral Patent Prosecution Highway Pilot Program was implemented by ARIPO and the China National Intellectual Property Administration. The program shall be a trial period of 5 years from 8 June 2024 - 7 June 2029. This enables an applicant who received a positive outcome on patent claims from one participating office to request expedited examination of corresponding claims in the other participating office, thereby allowing a patentability decision on the latter office more quickly.

#### ARIPO/OAPI: 7<sup>th</sup> OAPI-ARIPO Joint Commission<sup>7, 8, 9, 10</sup>

The 7<sup>th</sup> OAPI-ARIPO Joint Commission, held in Harare on 12-13 June 2024 reaffirmed the two offices' common desire to combine efforts to ensure better protection of intellectual property in their member states and in Africa. The meeting ended with signature of the 2024-25 Work Plan.

## ARIPO/Kenya: High-Level IP Training for African Enforcement Officials<sup>11, 12</sup>

AfrIPI partnered with ARIPO and the Kenyan Industrial Property Institute (KIPI) delivered a high-level training program on intellectual property enforcement for ARIPO member states. The program, held in Nairobi, Kenya on 28-30 May 2024 included a discussion on the latest international legal frameworks of IP rights enforcement, regional approaches to combat piracy and counterfeiting and leveraging technology for effective enforcement in the digital age.

#### Egypt: Strengthening Intellectual Property Partnership: The U.S Commits to Egypt's Creative Industries<sup>13</sup>

The United States IP Enforcement Office and the US Patent and Trademark Office (USPTO) reaffirmed its commitment to its partnership with Egypt during a visit to Cairo on 10-11 June 2024. Discussions included the creative industry landscape and the IP environment that supports and protect the creators; and emphasizing the mutual interest in promoting IP rights, economic growth and partnership between the USA and Egypt.

#### Egypt: China Extends Patent Prosecution Highway Pilot Programs with Egypt and Iceland<sup>14</sup>

The Chinese National Intellectual Property Administration announced an extension of the Patent Prosecution Highway Pilot projects with the Icelandic Patent Office and the Egyptian Patent Office. This was announced on 28 June 2024 and results in both projects being extended from 1 July 2024 to 30 June 2029.

## OAPI: Technical support for the reference collections of accredited research and review centers for plant varieties in OAPI<sup>15, 16, 17</sup>

The Community Plant Variety Office (CPVO) and Intellectual Property in Africa provides technical support for the reference collections of accredited research and review centers for plant varieties in OAPI. This was done through a training workshop from 7-9 May 2024 for the staff of the Senegalese Institute of Agricultural Research. Another training session was held from 30-31 May 2024 for the technical staff of the National Centre of Agronomic Research de Cote d'Ivoire. On 5-7 June 2024, training was also provided at the Institute of Agricultural Research for Development station in Mbalmayo, Cameroon.

The technical support includes making an inventory of reference collections of plant varieties available in the examination centers; writing procedure manuals for the implementation reference collections according to varieties of botanical species and carrying out training for this; and formulate recommendations for future actions to be carried out to build capacity.

## OAPI: Support for the network of OAPI judges - 4th conference<sup>18, 19, 20, 21</sup>

AfrIPI convened the Judges' Network for the fourth and final seminar on IP litigation and practice on 25-27 June 2024 in Libreville, Gabon. This helps strengthen IP litigation and IP-related issues within the judicial and administrative systems and to contribute to provide and synchronize digital case-law.

#### Zambia: Annual Report - The Patents and Companies Registration Agency (PACRA), Zambia<sup>22</sup>

In June 2024, The Patents and Companies Registration Agency (PACRA), Zambia published its Annual Report. The Report provides insight into the functions of the Agency, along with performance reports and statistics during 2022-2023; and discussions on its objectives. In 2023, 2,445 trade mark applications, 9 patent applications and 168 industrial design applications were filed. 2023 also saw 211 copyright lodgments being filed. This marks a significant increase in the number of intellectual property rights applications filed in 2023, which stood at 2,622 compared to 2,095 in 2022.
