## Egypt: Patent Examination Fees Doubled and Deadlines Shortened<sup>1</sup>

The Egyptian Intellectual Property Authority (EGIPA) has issued Decree No. 26 of 2025, published in Official Gazette No. 132<sup>2</sup> on June 17, 2025, introducing significant changes to patent examination procedures in Egypt.

Effective June 18, 2025, the official fee for patent examination has doubled from EGP 25,000 to EGP 50,000 (approximately USD 1,060 / JPY 168,000). Additionally, the deadline for paying examination and expert fees has been shortened from six months to three months from the date of official notification.

# GCC: New Committee on Intellectual Property and International Law Launched<sup>3</sup>

The International Law Association (ILA) GCC Branch has announced the formation of a new Committee on Intellectual Property and International Law. While the committee is not affiliated with the official bodies of

the Gulf Cooperation Council, it reflects the ILA's broader mission as a non-profit organization dedicated to the study and advancement of international law.

The Committee aims to promote research, training, and dialogue on international and regional IP matters, focusing on how domestic and regional legal frameworks align with global standards and best practices. It will also explore the intersection of intellectual property with sustainability, sports, alternative dispute resolution, and emerging technologies.

This initiative reflects the region's growing emphasis on strengthening IP systems to support innovation and economic growth. The Committee's work is expected to contribute to a more harmonized understanding of international IP law across the GCC.

## Türkiye: Court of Cassation Confirms Bad Faith in Trademark Application<sup>4</sup>

In a decision dated March 18, 2025, the 11th Civil Chamber of the Turkish Court of Cassation upheld a ruling that a trademark application was filed in bad faith, highlighting key criteria under Turkish Trademark Law

The case concerned the trademark 'Stayer+', filed in 2019 for classes 7 and 35. The opponent argued that the mark created a likelihood of confusion with its earlier well-known trademark 'Stayer', and that the application was made in bad faith. While the Turkish Patent and Trademark Office initially rejected the bad faith claim, the Regional Court of Appeal found otherwise, noting the high distinctiveness and sector-specific reputation of the 'Stayer' mark.

The court concluded that the applicant was likely to be aware of the earlier trademark and provided no valid justification for adopting a near-identical sign. It held that bad faith extended to the entire application, not just certain goods or services, and ordered full invalidation.

The Court of Cassation rejected the Office's final appeal, confirming that under Turkish law, the distinctiveness and reputation of a prior mark can support a finding of bad faith—even without a direct relationship between the parties.

This decision reinforces the importance of conducting thorough trademark clearance in Türkiye and highlights the risks of adopting marks similar to well-established brands.

#### Qatar: Strategic Dialogue with France Highlights Focus on Intellectual Property<sup>5</sup>

On June 12, 2025, Qatar and France held their third Strategic Dialogue in Paris, where both sides reaffirmed their commitment to expanding cooperation across key sectors—including intellectual property.

As part of Qatar's €10 billion (approximately USD 10.8 billion / JPY 1.69 trillion) investment commitment to the French economy, intellectual property was identified as a strategic sector for collaboration, alongside areas such as semiconductors, digital economy, artificial intelligence, and healthcare.

The discussions emphasized Qatar's focus on fostering innovation and IP protection in line with its National Vision 2030. The two countries agreed to align efforts through joint initiatives, public-private partnerships, and research programs that support the commercialization of IP assets and technology transfer.

This growing IP collaboration is expected to strengthen bilateral trade and investment while supporting long-term goals in innovation and economic diversification.

### Qatar: MOCI Hosts Workshop on Combating Trademark Infringement<sup>6</sup>

On June 18, 2025, the Ministry of Commerce and Industry (MOCI) in Qatar, in collaboration with the Brand Owners Protection Group (Gulf BPG), held a training workshop at its Lusail City headquarters focused on combating trademark infringement and identifying counterfeit products.

The workshop brought together officials from MOCI's Intellectual Property Rights Protection Department and Consumer Protection and Commercial Fraud Department, along with representatives from the Ministry of Interior and the General Authority of Customs.

The training included practical exercises on distinguishing genuine products from counterfeits, highlighted challenges faced during inspection campaigns, and presented the latest technologies used to detect trademark violations.

## UAE: INTA to Open MENA Regional Office in Dubai<sup>7</sup>

The International Trademark Association (INTA) has announced the opening of its new regional office in Dubai, United Arab Emirates, with operations set to begin in the second half of 2025. The announcement was made during INTA's Annual Meeting in San Diego.

The office will serve as a hub for IP-related training, policy engagement, and collaboration across the Middle East and North Africa. INTA stated that the move responds to growing membership in the region and aims to support trademark protection, anti-counterfeiting efforts, and capacity building.

#### Yemen: 12th Edition of the Nice Classification Now in Effect8

The Trademark Office in Aden has officially adopted the 12th Edition of the Nice Classification, effective April 28, 2025.

This update brings Yemen's trademark classification system in line with the latest international standards for the classification of goods and services, facilitating greater consistency for applicants filing in multiple jurisdictions.

#### Yemen: Legalization Now Required for All Trademark POAs in Sana'a TMO9

The Trademark Office in Sana'a has issued a regulatory update concerning Powers of Attorney (POAs) submitted for trademark matters.

Effective immediately, all POAs must be legalized at the Yemeni Embassy. General POAs that were previously legalized will no longer be accepted unless each individual POA is separately legalized.

To ensure broader representation and avoid limitations, it is also recommended to include the phrase "and for all subsequent works" in upcoming POAs. This language helps ensure the POA covers future actions beyond the initial filing.
