

# MESSAGE

The Tokyo International Conference on African Development (TICAD) has been advocating for development based on the twin principles of African ownership and international partnership. As priority has shifted toward "growth led by the private sector" in recent years, expectations for greater involvement by Japanese companies in local business have also been growing among African countries. Further, as Africa is expected to play a leading role in the world economy by 2100, with an impressive market that will account for one third of the world's population, interest among Japanese companies in doing business with Africa is rapidly climbing.

The Japan-Africa Business Forum & Expo, official side events of TICAD7, are being held in response to these domestic and international expectations.

Through these events, JETRO will promote the attractiveness and potential of African business to Japanese companies, and at the same time, introduce the excellent products and services of Japanese companies to African countries. By holding them together, we aim to have them jointly function as one multifaceted platform to enhance two-way business exchange between Africa and Japan at TICAD7.

The Business Expo will be composed of the following zones: "Japan Fair," where over 150 exhibitors will demonstrate the allure and potential of Japanese industry in an all-Japan effort; "Africa Lounge," where opportunities for investment and business will be presented by each African country; and "Africa Alliance Zone," which focuses on collaboration with other foreign countries aspiring to expand commerce with Africa. The "Event Stage," where various seminars on business and investment in Africa will be held, will also provide a venue for participants to become acquainted with a wealth of information on African business.

At the Business Forum, JETRO will rouse the interest of Japanese companies by inviting leading figures from political and industrial circles of Africa and Japan to introduce prospects and visions for business in the continent, along with pioneering fields and methods, such as cooperation between African startups and companies from other countries.

I sincerely hope that the Japan-Africa Business Forum & Expo will set the stage for discover and creation of new opportunities and be a catalyst for accelerating business exchange between Africa and Japan.

ビジネスフォーラムでは、日本およびアフリカ各国の政財界トップを登壇者に 迎え、アフリカビジネスの可能性やビジョンの共有、さらには、アフリカのスタート アップ企業や他国企業との連携など、新たなビジネス領域・手法について紹介し、 日本企業の一層の関心喚起を図ります。

今回の「日本・アフリカビジネスフォーラム&EXPO」が皆様にとって、新しい ビジネスの発見と創造の場となり、アフリカと日本のビジネス交流が益々発展する ことを願ってやみません。







The Agency registers private investment proposals and issues certificates that give the investor "green light" to start the project, the so called "CRIP", in addition the agency act as the investor's interlocutor by providing institutional support to facilitate the implementation of private investment projects.

The Gabonese government's action plan and support structures for investment promotion in Gabon took into account the orientations of the Gabon Emergent Strategic Plan - PSGE - and the commitments of His Excellency Ali BONGO ONDIMBA, President of the Republic, Head of state. The implementation of this economic and social development plan requires technical and financial support from external partners in its implementation. Identified projects are mainly in three sectors:

- 1- Green Gabon: They focus on the implementation of solar thermal power plants and the deployment of off-grid solar kits. The others are developed around the sustainable conservation of ecosystems through the preservation of protected areas and the environment.
- 2- Gabon services: The projects to be presented are developed around the services provided to the person in terms of transport and infrastructure, real estate, health, education, street furniture, local shops and development of financial services
- 3- Industrial Gabon: The identified projects will be submitted for eligibility for the financing mechanism for industrial sectors such as mining and natural resources, timber, agriculture and fisheries.

Gabon's investment support structures in these areas are mainly in addition to the Gabonese Embassy in Japan, the National Agency for the Promotion of Investments - ANPI - Caisse des Depots and Consignations - CDC - and the National Agency National Parks and Preservation of Nature - ANPN. Their technical sheets are online and will also be available in the stand



Nigeria provides a huge opportunity for a variety of industrial activities due to the availability of natural resources, affordable labour cost and large market. Its manufacturing sector is reemerging due largely to the improving performance of the consumer and household goods industries. It produces a large proportion of goods and services for the West African subcontinent. The industry sector contributes an annual average of 23% of the GDP. The major activities include oil & gas (9%), manufacturing (7%), and construction (5%). The sector is strategic to government's objective of diversifying the economy in line with the Economic Recovery & Growth Plan. The manufacturing sub-sector has been growing in recent times in direct response to various interventions/programmes implemented by government. The sub-sector's capacity utilization has grown from an average of 35% in the 1990s to an average of 54% in the last five years. Its contribution to national GDP has also grown steadily to an annual average of 9% in the same period. Nigeria's industrial aspiration is hinged on the implementation of the Nigeria Industrial Revolution Plan (NIRP) which philosophy is to build Nigeria's competitive advantage, to broaden the scope of industry, and accelerate expansion of the manufacturing sub-sector. NIRP establishes cross cutting interventions that address competitiveness of the entire manufacturing sub-sector.

The NIRP will ensure that Nigeria becomes:

the preferred manufacturing hub in West Africa;

the preferred source for supplying low and medium-technology consumer and industrial goods domestically and regionally. Government is not unaware of the major challenges inhibiting the growth and development of the manufacturing industry; there is a huge commitment to ensuring that Nigeria generates a minimum of 10,000MW of power and ensure effective distribution of this power before the end 2023. Government is also committed to removing all non-fiscal barriers to investment and ensuring a competitive business environment that would promote free entry and exit of investors irrespective of nationality.



The Mozambican economy has registered remarkable growth in the last decade benefitting from substantial inflows of FDI into various sectors, notably agriculture and agro-industry, tourism, infrastructure development, energy, which currently are the top investment priority, fisheries and aquaculture, industry, mineral resources (mainly coal and gas), banking, among others. The Investment Law grants certain tax and customs benefits depending on the amount, location and sector of investment activity. Mozambique's external position is characterized by an accelerated growth in the importation of capital goods and specialized services associated with increasing inflows of foreign direct investments, which in their turn, constitute one of the key funding sources for the country's current account deficit.

Exports have also seen a major rise because of increasing inflows of FDI with goods such as coal, natural gas, titanium minerals and aluminum taking the lead. In 2017, Mozambique's exports amounted to US\$ 4.7 billion, in the other hand the imports reached an amount of US\$ 9.1 billion.






