Halal Industry Players

 100% tax exemption on capital expenditure for a period of 10 years; or Income tax exemption on export sales for a period of 5 years.

• Exemption on import duty and sales tax on raw materials used for the development production of halal promoted products.

 Two-times deduction on expenses incurred in obtaining international quality standards such as HACCP, GMP, Codex Alimentarius (food standard guidelines of FAO and WHO), Sanitation Standard Operating Procedures and regulations on export markets compliance.

Halal Logistic Operators

- Full income tax exemption for a period of 5 years <u>or</u> 100% income tax exemption on capital expenditure for a period of 5 years
 and
- Exemption on import duty and sales tax on equipment, components and machinery used directly in the Cold Room Operations in accordance to prevailing policies

Halal Park Operator

- Full income tax exemption for a period of 10 years <u>or</u> 100% income tax exemption on capital expenditure for a period of 5 years
 and
- Exemption on import duty and sales tax on equipment, components and machinery used directly in the Cold Room Operations in accordance to prevailing policies. Operators should always comply to HDC's standards and guidelines for Halal Park

HALMAS QUALIFYING CRITERIA FOR INDUSTRY PLAYERS

- 1. Halal Industry Player must be involved in the following four (4) industry sectors only :-
 - •Specialty Processed Food
 - •Cosmetics/Healthcare/ Personal Care Products & Pharmaceutical
 - •Halal Ingredients
 - •Livestock and Meat Products
- 2. Employment of high value knowledge workers with a minimum of 15% of the total workforce including at least two (2) Halal Compliance Officers
- 3. Located in HDC Designated Halal Parks and Logistics Cold Hubs approved by HDC
- 4. Must not be involved in trading and consultancy activities
- 5. Must always comply with prescribed quality, hygiene and environmental guidelines
- 6. Must always comply with all laws, regulations and licensing requirements where applicable
- 7. Must comply with HDC's Halal Integrity criteria with tests from accredited laboratories in determining the credibility of the promoted halal products; and
- 8. Must be involved in new business activities related to Halal and must incorporate a new legal entity in Malaysia
