

## Alberta Agriculture and Forestry Ministry Goals and Business


- The Ministry contributes to three of the Alberta Government's four key opportunities:
  - Unleashing Innovation
  - Competing in a Global Marketplace
  - Making Alberta the Best Place to Live, Work and Visit
- The Ministry achieves this by working with others to promote prosperity for Alberta through a strong, competitive, sustainable forestry, agriculture and food industry.
- The Ministry has three core businesses:
  - A market-driven, environmentally responsible industry
  - Food safety, forest and plant health, and animal health and welfare
  - Rural development





## Alberta Agriculture and Forestry Mandate

- Government of Alberta is responsible for stewardship of Alberta's air, lands, forests, water and biodiversity for the benefit of Albertans
- Balanced, sustainable and responsible use of Alberta's natural resources
- The Alberta forest sector focuses on product innovation and green, renewable energy to adapt to changing markets



# Alberta

## Alberta Agriculture and Forestry Forestry Division Structure

#### Forest Industry Development Branch

- Liaison to the forest industry and forest policy development
- Renewal of forest management agreements and timber quotas
- Assessments of fibre utilization and operating efficiency
- Royalty rate reviews and coordination with the federal government and industry

#### Forest Management Branch

- Administration and management for forest health, adaption and seed storage
- Forest programs hydrology, ecology, communications and reforestation
- Forest management including planning, timber harvesting and reclamation
- Resource and landscape-level analysis of complex wood supply issues
- Timber production and auditing, scaling standards, and revenue compliance

#### Wildfire Management Branch

- Respond to every wildfire reported in the Forest Protection Area
- Five priorities guide Forestry Division in the allocation and use of firefighting resources. In order of highest priority:
  - Human life
  - Communities
  - Watersheds and sensitive soils
  - Natural resources
  - Infrastructure





#### Alberta Agriculture and Forestry Green Area and White Area

#### **Green Area:**

- Provincial government regulated
- Public land, owned by Crown
- Comprises
  352,101 sq
  km of Alberta
- Managed for sustainable resource development




#### White Area:

- Municipal and provincial government regulated
- 75% of the white area is privately owned
- Comprises 255,666 sq km in Alberta
- Managed for agricultural and rural development



#### Alberta Agriculture and Forestry Natural Regions and Biodiversity

- Alberta has six major ecosystem types called Natural Regions, each with distinctive geographical and climatic conditions that support an abundant variety of plants and animals. Only 3,000 species or 4% of Alberta's biodiversity have been described and named.
  - Boreal
  - Canadian Shield
  - Foothills
  - Grassland
  - Parkland
  - Rocky Mountain





## Alberta Agriculture and Forestry Annual Allowable Cut

- Alberta has 61 million hectares and 38 million hectares of that land is forested
- The sustainable Annual Allowable Cut is 31 million cubic metres
- Current harvest is 25 million cubic metres
- 19 million cubic metres are coniferous species and 12 million cubic metres are hardwood species
- Alberta continuously adapts and enhances wildfire management strategies through innovation











## Alberta Agriculture and Forestry Status of Alberta's Timber

- Alberta ensures the volume of wood removed / harvested in any one year does not exceed the volume of wood that grows annually
- Strict operating ground rules dictate forest operations
- Reforestation and the re-establishment of forests is legislated and mandatory in Alberta and across Canada.
- Alberta plants approximately 70 million seedlings per year within 2 years of harvest (~1500 per ha)









## Alberta Agriculture and Forestry Certification of Wood Products

- Alberta's forest lands are predominantly third party certified 82%
- CSA Canada's National Sustainable Forest Management Standard (CAN/CSA-Z809)
- SFI The Sustainable Forestry Board's Sustainable Forestry Initiative Program
- FSC The Forest Stewardship Council's Principles & Criteria and/or Standards











## Alberta Agriculture and Forestry Economic Contribution - 2015

- 15,000 direct and indirect Alberta jobs
- Sector contributes \$4 5 billion annually to the Alberta economy
- 70 forestry communities in Alberta
- Approximately \$850 million in taxes are paid to government (income tax, property tax, stumpage, etc.)







## Alberta Agriculture and Forestry Competitive Advantage

- Fibre strength and quality superior to faster growing species
- Extensive publicly owned resource
- Stable and transparent tenure and regulatory system
- Competitive delivered wood costs
- Efficient facilities and infrastructure
