


2. Meet-up Service with J-Bridge Members

Outline of collaboration/alliance

In order to achieve the goal of reducing greenhouse gas emissions set by the Vietnamese government, Green Carbon Inc., a Japanese startup with solutions for promoting carbon neutrality, conducts a joint study with the Vietnam National University of Agriculture to curb methane gas emissions in rice paddies.

The business and research areas are not limited to rice paddies, but also include cooperation in a wide range of fields that contribute to carbon neutrality in Southeast Asia, such as agrochemicals and eructation of cattle.

Outline of collaboration/alliance

At the Research and Innovation Park in the Indian Institute of Technology (IIT) Delhi, Mitsui Mining and Smelting Co., Ltd. established an R&D center of Mitsui Kinzoku Components India (MKCI), the company's Indian subsidiary. Researchers from Japan and IIT Delhi work together to develop water electrolyzers.

IIT Delhi provides technical expertise and researchers in the field of electrochemistry that it has cultivated, while Mitsui Mining and Smelting utilizes its knowledge of materials, including precious metal-saving catalyst technology that it has cultivated, developing new materials jointly by leveraging the strengths of both parties. At the same time, after providing the development funds and space, Mitsui Mining and Smelting dispatches researchers to MKCI Delhi Development Center to proceed with the joint development.

Outline of collaboration/alliance

HAKKI AFRICA purchased 200 electric bicycles from ARC Ride Global and sold them in installments to low-credit borrowers who cannot obtain bank loans, through a financing service using the company's proprietary credit scoring system, thereby expanding its business domain from conventional financing services for used four-wheeled vehicles. ARC Ride Global, on the other hand, will improve the electric bicycles, increase the durability of batteries, and improve the efficiency of charging stations based on feedback from purchasers provided by HAKKI AFRICA.

In addition to aiming for the top market share in the region, the two companies will contribute to the promotion of financial inclusion in Africa.

Outline of collaboration/alliance

NuRetail, a Retail Tech startup, operates a supermarket in Tokyo (Kichijoji) called ASIA SUNSHINE MARKET, which sells Asian food products. The company was looking for a DX solution for physical stores, and it chose Palexy that has strengths in AI-based in-store customer flow analysis for retail stores.

Utilizing JETRO's "Subsidy for Projects to Stimulate Foreign Direct Investment in Japan," the company will promote the visualization and efficiency of physical stores using AI, check the suitability of Palexy products for the Japanese market, and jointly develop omni-channel products.

Overview of establishment of base

In order to realize decarbonization for the Mitsui O.S.K. Lines (MOL) Group as well as society as a whole, MOL Switch LLC was established in May 2023 to accelerate investment in start-up companies that develop technologies to solve energy problems and contribute to decarbonization.

> Reasons for deciding to establish a base

- The most advanced startup ecosystem in the world that the U.S. has, centered on Silicon Valley, where cutting-edge technologies including those related to decarbonization are emerging, and its market full of opportunities to access innovation and explore businesses.
- The necessity to establish local bases and work together with expatriates and local staff in order to enhance the network with the local ecosystem and create business opportunities.


As investment in startups in the sustainability/green field is gaining momentum in Europe, the company established an office in the coworking space operated by Sustainability Ventures, one of Europe's largest accelerators and VCs specializing in ClimateTech, in order to reach out to startups in the field more efficiently. Centered on this office, the company will promote startup discovery throughout Europe.

Reasons for deciding to establish a base

The largest number of startups in European countries that the U.K. has, centering on London and its surrounding Cambridge and Oxford areas. In addition, fewer language hurdles to penetrate deeply into the local startup community because the native language is English.
