

Notification of Ministry of Industry
Subject: List of hazardous substances
(No.3)
B.E. 2559 (2016)

By the virtue of section 5 paragraph two and section 18 paragraph two of the Hazardous Substance Act B.E. 2535 (1992), the Minister of Industry, with the opinions of the Committee on Hazardous substance, hereby issues the ministerial notification as follows:

Article 1 Hazardous substances as annexed to the Notification of Ministry of Industry regarding the list of hazardous substances B.E. 2556, dated 28th August B.E. 2556 (2013), shall be revoked and replaced by the list of hazardous substances prescribed in the annex of this Notification.

1.1 **No. 3: 1,1,2-trichloroethane, No. 157: methanol or methyl alcohol** prescribed in List 4.1 Controlled Substances under the List 4, which is responsible by the Food and Drug Administration.

1.2 **No. 5: Products used for text correction or removal or as solvent for chemicals used for text correction or removal or dry cleaning of fabric or other textile products** that are prescribed in List 4.3: Group of Controlled Products under the List 4, which is responsible by the Food and Drug Administration.

1.3 **No. 6: Hydrofluorocarbons** prescribed in List 5.4: Others under the List 5, which is responsible by the Department of Industrial Works.

Article 2 Following hazardous substances listed in the annex of this Notification shall be added to the List of hazardous substances which is annexed to the Notification of Ministry of Industry B.E. 2556, dated 28th August B.E. 2556 (2013), which has been amended by the Notification of Ministry of Industry (No. 2) B.E. 2558, dated 5th January B.E. 2558.

2.1 **No. 225: formaldehyde or methanol prescribed** in List 4.1: Controlled Substances under the List 4, which is responsible by the Food and Drug Administration.

2.2 **No. 489: cresol or methyl phenol, No. 490: HFC-245eb, No. 491: HFC-338mcc, No. 492: HFC-338mee, No. 493: HFC-356ffa, No. 494: HFO-1234yf, No. 495: HFO-1234ze, and No. 496: HFO-1336mzz-Z** prescribed in List 5.1: Controlled Substances under the List 5, which is responsible by the Department of Industrial Works.

Article 3 Producer, importer, exporter or possessor of hazardous substance type 2 or type 3 stipulated in this Notification, whose operations have been performed before the enforcement of this Notification, shall submit a notification of operation for hazardous substance

type 2 or submit the application for operation permit for hazardous substance type 3 within 30 days since the enforcement date of this Notification. If registration is required for any hazardous substances, the application for registration shall be submitted within such period as well.

Producer, importer, exporter or possessor of hazardous substance type 4 according to this Notification whose operations are performed before the enforcement of this Notification shall comply with the order of the official within 180 days since the enforcement date of this Notification.

This shall, thus, enter into force on the day following the date of its publication in the Government Gazette.
