Notification of Ministry of Industry

Re: Prohibited area to establish or expand a factory of oil extraction from Krissana wood and specified source of raw material for a factory of oil extraction from Krissana wood B.E. 2545 (2002)

By the virtue of Section 32 (1) and (2) of the Factory Act B.E. 2535(1992), which contains some provisions concerning the limitation of the people rights and liberties that is permissible by the provisions of section 29 together with section 35, section 48 and section 50 of the Constitution of the Kingdom of Thailand, the Minister of Industry, with the approval of the cabinet, hereby issues the Ministerial Notification as follows:

Article 1 It shall be prohibited to establish or expand a factory engaging in business of oil extraction from Krissana wood of all sizes wood under factory type 7(1) of the attached list annexed to the Ministerial Regulation (B.E.2535 (1992)) issued pursuant to the Factory Act B.E. 2535(1992) in the following area.

- (1) Krabi province: only Muang district, Koh Lanta district, and AoLuk district
- (2) Kampangetch province: all districts
- (3) Jantaburi province: all districts
- (4) Chonburi province: all districts
- (5) Chaiphaphum province: only Kasetsomboon district and Nhonbuadang district
- (6) Chiangrai province: only Khuntan district, Teng district, Pan district and Wiengphapao district
- (7) Chiangmai province: only Chiangdao district, Wienghae district, Hod district and Mae-on subdistrict
- (8) Trang province: all districts
- (9) Trad province: only Lam-ngob district
- (10) Nakornratchasima province: only Kornburi district, Wang Nam Khiaw district and Sengsang district
- (11) Nakornsrithammarat province: only Thasala district, Thungsong district, Promkiri district, Ronpiboon district, Lansaka district, Sichon district, Chang-klang subdistrict and Nobpitam subdistrict
- (12) Nakornsawan province: only Ladyao district
- (13) Narathiwas province: all districts
- (14) Nan province: all districts
- (15) Prajeenburi province: only Nadee district
- (16) Pattani province: all districts
- (17) Phang-nga province: only Kuraburi district
- (18) Pattalung province: all districts

- (19) Pissanulok province: only Nakornthai district and nernmaprang district
 - (20) Petchaboon province: Kaokho district, Nam-nhao district and Lhomsak district
 - (21) Prae province: all districts
 - (22) Phuket province: only Thalang district
 - (23) Maehongsorn province: all districts
 - (24) Yala province: all districts
 - (25) Rayong province: all districts
 - (26) Lampang province: only Ngao district and Thern district
 - (27) Lampoon province: only Baanhong district and Lhee district
 - (28) Loei province: only Na-haew district and Phukradeung district
 - (29) Songkhla province: all districts
 - (30) Satun province: all districts
 - (31) Srakaew province: only Muang district and Wattananakorn district
 - (32) Suratthani province: only Donsak district and Baan-na-sran district
 - (33) Nhonkhai province: only Seka district, Beungkarn district, Beungkhonglhong district and Bhungkla district.
 - (34) Uttaradit province: only Nampad district and Baancok district

Article 2 All types of factory of the attached list annexed to the Ministerial Regulation (B.E.2535 (1992)) issued pursuant to the Factory Act B.E. 2535(1992) that use Krissana wood as raw material shall use such Krissana wood obtained only from aboard with a document proven its legal import.

Article 3 This Notification shall, thus, enter into force on the day following the date of its publication in the Government Gazette.
