## **Notification of Ministry of Industry**

Re: Type of factory requiring installation of wastewater continuous monitoring equipment and type of equipment to be installed (Number 2)

**B.E.** 2548 (2005)

By the virtue of clause 15 di and clause 15 di (1) paragraph two of the Ministerial Regulation No. 2 (B.E. 2535 (1992)) issued pursuant to the Factory Act B.E. 2535(1992), amended by the Ministerial Regulation No. 11 (B.E. 2539 (1996)) issued pursuant to the Factory Act B.E. 2535(1992), which contains some provisions concerning the limitation of the people rights and liberties that is permissible by the provisions of section 29 together with section 35, section 48 and section 50 of the Constitution of the Kingdom of Thailand, the Minister of Industry hereby issues the Ministerial Notification as follows:

- Article 1 To amend the following statement as 1.3 and 1.4 of the Ministerial Notification regarding type of factory requiring installation of wastewater continuous monitoring equipment and type of equipment to be installed B.E. 2547 (2004).
  - "1.3 A factory with effluent discharge of 1,000 3,000 cubic meters per day.
  - 1.4 A factory with effluent discharge of 500 1,000 cubic meters per day."
- Article 2 To repeal the statement in 2.2 of the Ministerial Notification regarding type of factory requiring installation of wastewater continuous monitoring equipment and type of equipment to be installed B.E. 2547 (2004) and replace with the following statement.
- "2.2 Installation of monitoring equipment for Biochemical Oxygen Demand and/or Chemical Oxygen Demand determination that can be continuously transmitted data to computerized system of Department of Industrial Works for continuous data recording. Installation of monitoring equipment either for Biochemical Oxygen Demand or Chemical Oxygen Demand determination, or both, shall be approved by Department of Industrial Works."
- Article 3 The enforcement of 1.3 and 1.4 of the Ministerial Notification regarding type of factory requiring installation of wastewater continuous monitoring equipment and type of equipment to be installed B.E. 2547 (2004) shall be as follows:
  - 3.1 Become enforceable on 14<sup>th</sup> January B.E. 2549 (2006) for factories
- 3.2 Become enforceable on 14<sup>th</sup> July B.E. 2549 (2006) for factories under 1.4.
