Notification of Ministry of Industry

Subject: Declaration of the hazardous substances

under the authorization of Department of Industrial Works

by producer, importer, exporter or possessor

B.E. 2547 (2004)

To revise the notification of Ministry of Industry B.E. 2543 (2000), issued pursuant to Hazardous Substance Act B.E. 2535 (1992), dated 20th March B.E. 2543 (2000), regarding declaration of hazardous substance under the authorization of Department of Industrial Works by producer, importer, exporter or possessor, for better coherence.

By the virtue of Section 5 paragraph three and Section 20 (1) of the Hazardous Substance Act B.E. 2535 (1992), which contains some provisions concerning the limitation of the people rights and liberties that is permissible by the provisions of section 29 together with section 31, section 35, section 39, section 48 and section 50 of the Constitution of the Kingdom of Thailand, the Minister of Industry, with the opinions of the Committee on Hazardous Substance, hereby issues the ministerial notification as follows:

- Article 1 To repeal the notification of Ministry of Industry B.E. 2543 (2000) dated 20th March B.E. 2543 (2000) regarding declaration of hazardous substance under the authorization of Department of Industrial Works by producer, importer, exporter or possessor.
- Article 2 Hazardous substance in this notification shall mean the hazardous substances under the authorization of Department of Industrial Works, as designated in the ministerial notification announced by the virtue of Section 18 paragraph two.
- Article 3 An importer or an exporter of the hazardous substance shall declare the information relating to the particular hazardous substance to the competent authority prior to conducting such activity at the port. The information should contain the name, chemical formula and proportion, trade name, common name or abbreviation (if any), quantity, characteristic of containers, location of storage facility, transportation means, customs port, and anticipated arrival date to or departure date from the port as prescribed in the form WoAo./AoKo.6 attached to this notification.

Declaration as referred in paragraph 1 shall be submit to Department of Industrial Works or any other places appointed by Department of Industrial Works, or may submit via the computerized system through the computer network of Department of Industrial Works.

Article 4 Producer, importer, exporter, or possessor of the hazardous substances designated on the list attached to this notification, shall declare the information about its name, chemical formula and proportion, trade name, common name or abbreviation (if any), registration number (if any), produced, imported, exported, or possessed quantity, sold quantity, its customer and his/her purpose of purchasing, to the competent authority by using the form WoAo./AoKo.7 as attached to this notification.

Information, as described in paragraph one, of activities conducted during a period of January to June must be reported within the month of July of the same year. Those of activities

conducted during a period of July to December must be reported within the month of January of the next year. Declaration shall be submitted to Department of Industrial Works or any other places appointed by Department of Industrial Works, or may submit via the computerized system through the computer network of Department of Industrial Works or via registered mail.

- Article 5 Declaration submitted via the computerized system through the computer network of Department of Industrial Works, as referred in Article 3 paragraph 2 or Article 4 paragraph 2, shall be done in accordance with criteria, procedure and condition prescribed by Department of Industrial Works.
- Article 6 To submit the form via registered mail, as referred in Article 4 paragraph 2, the date stamped by the post office shall be considered the date of declaration to the competent authority.
- Article 7 Any declaration shall also take international conventions and covenants into consideration. Department of Industrial Works reserves the right to announce any criteria, procedure or condition for declaration referred in Article 3 and Article 4, or to revoke any such criteria, procedure or condition on reasonable ground by prescribing its justification in such announcement.

This shall, thus, enter into force after thirty days following the date of its publication in the Government Gazette.
