Subject: List of Hazardous Substances (No.5)

B.E. 2562 (2019)

By the virtue of section 5 paragraph two and section 18 paragraph two of the Hazardous Substance Act B.E. 2535 (1992), the Minister of Industry, with the opinions of the Hazardous Substance Committee, hereby issues the ministerial notification as follows:

- Article 1 Hazardous substances annexed to the Notification of Ministry of Industry regarding the List of Hazardous Substances B.E. 2556, dated 28th August B.E. 2556 (2013) as followings shall be revoked and replaced by the list of hazardous substances prescribed in the annex of this Notification.
- 1.1 List 4.1 of List 4 under the responsibility of the Food and Drug Administration, Controlled Substances: No. 24 chlorpyrifos and No. 25 chlorpyrifos-methyl;
- 1.2 List 4.2 of List 4 under the responsibility of the Food and Drug Administration, Group of Controlled Substances: No. 15 amphoteric surfactants;
- 1.3 List 5.1 of List 5 under the responsibility of Department of Industrial Works, Controlled Substances: No. 60 methoxy acetic acid or 2-methoxyacetic acid or methyl ether and No. 477 hexachlorobenzene.
- Article 2 Hazardous substances annexed to this Notification shall be added in the list of hazardous substances annexed to the Notification of Ministry of Industry regarding the List of Hazardous Substances B.E. 2556, dated 28th August B.E. 2556 (2013), latest amended by the Notification of Ministry of Industry regarding the List of Hazardous Substances (No. 4) B.E. 2560 (2017) dated 15th November B.E. 2560 (2017) as followings:
- 2.1 List 4.1 of List 4 under the responsibility of the Food and Drug Administration, Controlled Substances: No. 226 citric acid (monohydrate), No. 227 citric acid (anhydrous), No. 228 (D(-) lactic acid), No. 229 (DL-lactic acid) or racemic lactic acid and No. 230 (L(+) lactic acid);
- 2.2 List 4.2 of List 4 under the responsibility of the Food and Drug Administration, Group of Controlled Substances: No. 29 amine oxides;
- 2.3 List 5.1 of List 5 under the responsibility of Department of Industrial Works, Controlled Substances: No. 519 Decabromodiphenyl ether, No. 520 chloroalkanes, C_{6} - C_{18} , No. 521 chloroalkanes, C_{10} - C_{12} , No. 522 chloroalkanes, C_{10} - C_{13} , No. 523 chloroalkanes, C_{10} - C_{14} , No. 525 chloroalkanes, C_{12} - C_{14} .
- Article 3 Producers, importers, exporters or possessors of hazardous substance type 2 or type 3 in accordance with this Notification, whose operations have been performed before the enforcement date of this Notification, shall notify the operation of hazardous substance type

2 or submit an application for permission for hazardous substance type 3 within 90 days since the enforcement date of this Notification. And any hazardous substance is required to be registered, an application for registration shall be submitted within such period as well.

Producers, importers, exporters or possessors of hazardous substance type 4 accordance with this Notification whose operation have been performed before the enforcement date of this Notification shall comply with the order of the competent official within 180 days since the enforcement date of this Notification.

Article 4 This shall, thus, enter into force on the day following the date of its publication in the Government Gazette.
