Notification of Department of Industrial Works

Re: Criteria and Method for Notifying and Registration of Specialized Person Responsible for Safety Storage of Hazardous Substance under Authorization of Department of Industrial Works and Reporting of Safety Storage of Hazardous Substance

B.E. 2551 (2008)

According to the 5.1) and 5.5) of Section 2 and 6.6) of Section 3 of the Notification of Ministry of Industry regarding Designation of Specialized Person Responsible for Safety Storage of Hazardous Substance under Authorization of Department of Industrial Works at Hazardous Substance Business Facility B.E. 2551 (2008), Department of Industrial Works hereby announces criteria and method for notifying and registration of specialized person responsible for safety storage of hazardous substance under authorization of Department of Industrial Works and reporting of safety storage of hazardous substance as follows:

Article 1 If not otherwise defined, in this Notification,

"Hazardous substance" shall mean hazardous substance under authorization of Department of Industrial works as designated in the Ministerial Notification issued pursuant to Article 18 Paragraph 2 of the Hazardous Substance Act B.E. 2535 (1992).

"Hazardous substance entrepreneur" shall mean producer, importer, exporter or possessor of hazardous substance.

"Storage facility" shall mean a warehouse used to keep hazardous substance

"Specialized person" shall a person responsible for safety of hazardous substance storage who has passed a test of a safety of hazardous substance storage course as criteria and method specified by Department of Industrial Works.

"An examination" shall mean an examination of a safety of hazardous substance storage course as prescribed by Department of Industrial Works.

"Registration certificate" shall mean a certificate of a registration of a specialized person issued by Department of Industrial Works to a person who applies for a registration of a specialized person responsible for safety storage of hazardous substance under authorization of Department of Industrial Works.

"Report of safety storage of hazardous substance" shall mean a report declaring information of hazardous substance storage that is submitted to Department of Industrial Works.

Article 2 This notification shall enter into force three years after its publishing in the Government Gazette.

Section 1

Criteria and method for notifying a specialized person

Article 3 Hazardous substance entrepreneur, as mentioned in Article 4 of Section 1 of the Notification of Ministry of Industry regarding Designation of Specialized Person Responsible for Safety Storage of Hazardous Substance under Authorization of Department of Industrial Works at Hazardous Substance Business Facility B.E. 2551 (2008), shall submit the BorChor.1 Form notifying a designation of a specialized person responsible for safety storage of hazardous substance under authorization of Department of Industrial Works.

- Article 4 Notifying of a person mentioned in Article 3 shall be conducted at the Department of Industrial Works or others as specified by the Department.
- Article 5 Department of Industrial Works shall provide a password to a person who submits a notification as mentioned in Article 3. This password shall be used for submitting a report of safety storage of hazardous substance via a computerized system to the Department's computer networking system as specified in Section 3.

Article 6 In case that a hazardous substance entrepreneur who has submitted a notification of a designation of a specialized person as mentioned in Article 3 wishes to revise any information already submitted in the BorChor.1 Form, the procedure specified in this Section shall be applied mutatis mutandis. The former notification of this entrepreneur will be terminated once the Department of Industrial Works receives a revision.

Section 2

Registration of a specialized person

Article 7 Qualifications of a specialized person are as follows:

7.1) Graduate with a bachelor's degree with at least 8 credits in chemicals, or

finish at least a high school education and have at least 3-year experience on hazardous

substance storage.

7.2) Pass with a minimum score of 80% of an examination of a safety of

hazardous substance storage course as prescribed by Department of Industrial Works.

Article 8 Registration of a specialized person responsible for safety storage of

hazardous substance shall be applied with a BorChor.2 Form annexed with this notification

together with the following document:

8.1) A copy of I.D. card

8.2) A copy of a house registration

8.3) A copy of a diploma and a transcript, or a copy of a certificate of high school

education and a certified document of working experiences on hazardous substance storage

signed by hazardous substance entrepreneur during the 3-year working.

8.4) A document certifying a pass of an examination mentioned in 7.2)

Article 9 Submission of the Form mentioned in Article 8 shall be done at

Department of Industrial Works and the Department will issue a registration certificate as shown

in BorChor.3 Form annexed with this notification to the applicant after the qualification and

document mentioned in Article 7 and Article 8 are approved. Then the Department will issue a

password to the applicant for a procedure mentioned in Section 3.

Article 10 Department of Industrial Works will revoke a registration certificate of the

applicant if it is found that qualification of the registered person does not comply with Article 7

or that a registered person fails to perform his/her duty and responsibility.

Section 3

Submission of a report of safety storage of hazardous substance

Article 11 Hazardous substance entrepreneur shall submit a report of safety storage of hazardous substance using the BorChor.4 Form annually at the end of a calendar year via a computerized system to the computer networking system of Department of Industrial Works.

In case that a computer system is not in service, a report shall be submitted at Department of Industrial Works.

- Article 12 For a safety of report submission, the following procedure shall be taken:
- 12.1) A specialized person enters a computer system by typing his/her login name and password
- 12.2) Input electronic data in a BorChor.4 Form following procedure shown in a computer screen.
- 12.3) Check and confirm data input of 12.2), and notify hazardous substance entrepreneur to certify the data.
- 12.4) Hazardous substance entrepreneur enters his/her login name and password to certify the data input after being notified in 12.3)
- Article 13 A report mentioned in Article 12 shall be printed out and keep at the hazardous substance facility for investigation of the official at any time.
- Article 14 Certifying of data mentioned in 12.3) and 12.4) shall be considered as a certifying of a report of safety storage of hazardous substance of a specialized person and hazardous substance entrepreneur.
- Article 15 Revision of any data after a certifying as prescribed in this Section shall be conducted at Department of Industrial Works only.

Section 4

General part

Article 16 Department of Industrial Works reserves the right to stop a report submission method via a computerized system as prescribed in Section 3 if found that this

method would cause damage to the Department or the nation or that it is against public order, good moral and the peace and security of the nation either directly or indirectly.

Article 17 Department of Industrial Works reserves the right to change any criteria and method in accordance with this notification for the smooth operation and benefit of the government or hazardous substance entrepreneur or a specialized person. If such change has caused any damages, the Department of Industrial Works would not take any responsibilities whether civil, criminal or administrative liability.
