We also wish to encourage Patent Applicants in Japan to use the facilitate of PPH or ASPEC to accelerate their patents prosecution in Indonesia.

Please be advised that on 2 November 2020, the President of Indonesia, Joko Widodo has released Omnibus Law which regulations have affected certain aspects of Trademark and Patent matters in Indonesia, including the issue on Patent Working for Patent Right Holder in Indonesia. The implementation of these new practice is still waiting the issuance of supported regulations, which scheduled will be issued by this February.

The respective new practices could be related to the Government Policy on joining RCEP on 15 November 2020, as a continuing step on the signing of Omnibus Law on last November 2020 under Job Creation Law No. 11 of 2020.
