
#### **Conclusion & Comments**

<Background>

タイにおいては包括的記載が認められていない。

Many company joined SEAIPJ concern about Trademark Practice in Thailand.

Especially, the way to designate list of goods is recognized as difficult issue because there is big difference between Thailand and the other countries practice.
