

RHODE ISLAND

IDEAL LOCATION

Rhode Island lies between New York City and Boston and is part of the Northeast Corridor, an area that generates \$3.75 trillion in economic output, meaning that if it were a separate country, "it would be the fourth largest economy in the world."


- Densely populated (8th highest density of college students in the nation) with a skilled workforce and flexible training programs.
- PVD is within 15 minutes of two (2) deep water ports
- T.F. Green International Airport is just 7 miles south of Providence.
- The Northeast I-95 corridor makes for easy access to New York and Boston as well as to airports and shipping terminals that serve international markets.
- Providence is located within ¼ of a mile to the Northeast Corridor rail line – Amtrak, MBTA



In 2017 Infosys announced the opening of an Innovation and Technology Center in Providence

Infosys was awarded a Qualified Jobs incentive

- Worth \$8.5 Million
- To bring 500 new full-time employees for technology and software engineers/design staff to Rhode Island
- With an average salary of \$79,400

Community College of Rhode Island & Infosys:

eMONEY & RI


After a national search, eMoney chose to create a new office in downtown Providence.

By 2020, eMoney's Providence office was expected to be staffed by at least 100 new full-time employees. eMoney **reached their hiring goal significantly ahead of schedule**, moved into a new space, and now have sufficient space to hire up to 250 employees.

eMoney's talent needs included software developers, user interface and experience designers, and quality assurance analysts, as well as management and support positions.

"We originally thought we would be aggressive and hire 100 people by 2020. Today we stand here with 110 people," O'Brien said in May 2019.





INCENTIVES TO SUPPORT GROWTH

Rhode Island has tools to make a difference in location decisions.



Qualified jobs employment tax credit

Companies expanding their workforce in Rhode Island or relocating jobs from out of state can receive annual, redeemable tax credits for up to 10 years with the Qualified Jobs Incentive program. Credits can equal up to \$7,500 per job per year and up to 75% of the personal income taxes generated by the jobs. The minimum number of new jobs needed to qualify varies by industry and company size but can be as few as 10 jobs.



Rebuild RI real estate development tax credit

Rebuild Rhode Island can fill a financing gap with redeemable tax credits sometimes covering up to 20% of projects costs. Commercial office, industrial, mixed use development, and residential ground-up construction and historic rehab can qualify. A minimum project cost of \$5 million and certain square footage/project size minimums may apply.



REBUILD – VIRGIN PULSE

Fill a financing gap with redeemable tax credits sometimes covering up to 20% of projects costs.


- Virgin Pulse is a B2B health and wellness tech company.
- When Massachusetts-based Virgin Pulse acquired Providence-based Shape Up, the new Virgin Pulse operation decided to headquarter in Providence. The new home will initially consist of approximately 29,000 square feet, with plans to increase to approximately 88,000 square feet.
- The total Rebuild Tax Credits awarded shall not exceed \$3,240,598. In addition, based on current project estimates, the Applicant would qualify for an estimated \$341,798 in sales tax exemption under the Rebuild Program



WAVEMAKER FELLOWS

Wavemaker Fellowship provides student loan support for your employees.

- Available to employees who work in STEM or design fields at companies in Rhode Island.
- Fellows can receive up to \$6,000 per year for up to four years to defray student loan debt burden.
- Fellowship provides personal and professional development programs, networking opportunities, community-based events and more.
- Program contributes to recruitment and retention efforts for companies, and allows them to offer a location-based "free" benefit.
- Since inception, we've awarded 893 Wavemaker Fellowships to Fellows working at more than 300 different companies.



SUPPLYR

SupplyRI connects Rhode Island suppliers with opportunities that help them grow and expand.

SupplyRI is a public-private initiative funded by the Rhode Island Commerce Corporation, the Heron Foundation and the Rhode Island Foundation.

While the Supply RI initiative aims to connect local suppliers with the state's largest employers, it is also a great avenue to connect small businesses in Rhode Island. The events promote networking and resources to further business success at all levels.
