# Revision of Customs Duties and Excise Duties - 31.03.2012

## 1. Motor Vehicles

The total number of motor vehicles imported to the island has been increased by 121% and 147% respectively in 2010 and 2011 compared to the year 2009. Import of motorcycles has gone up by 61% and 81% respectively in 2010 and 2011 compared to the year 2009 while import of three-wheelers has been has been increased by 163% and 298% respectively in 2010 and 2011 compared to the year 2009. And also the number of imported motor cars which was 37,134 in 2010 has risen upto 54,285 by 46% by the year 2011.

Accordingly, taking into consideration the rapid increase of motor vehicles imported to this country since 2009, the traffic congestion and the high demand for fuel which resulted in thereafter, the Government has taken steps to revise the excise duties on motor vehicles, three-wheelers and motor bicycles as follows so as to be effective from 31 March 2012 with the intension of discouraging such imports in order to lessen import expenses.

However, No any change would be done on the taxes levied on agricultural tractors, busses, lorries and trucks.

2. Spare parts of used motor vehicles

An increase in the cut parts of motor vehicles, bodies and other spare parts imported to the island has taken place recently. Customs duties have been revised so as to charge the highest value out of the unit value (Specific Duty) or percentage value (Advolarum Duty) having revised the existing duty in order to discourage the aforesaid imports. The HS code numbers relevant to the revision are 8706.00.50, 8707.10, 8707.90.10, 8707.90.90, 8708.29.10, 8708.99.90.

3. Revision of the age limit subject to the control of motor vehicle importation.

The age limit subject to the control of motor vehicles imported to Sri Lanka is revised as mentioned below. These revisions do not apply for the busses under the HS heading no. 87.02.

# 4. Liquor and Cigarettes

As per the periodical tax revisions made annually ensuring the earning of estimated tax revenue from liquor and cigarettes, Customs import duty on imported Beer has been increased by Rs. 50/- per litre and Excise duty on local Beer and hard liquor have been increased by Rs. 5/- and Rs. 60/- per litre, respectively, as follows. The expected tax revenue for 2012 from these tax rate revisions on liquor and cigarettes is around 3 billion.

#### **Order under Section 3**
