**To limit the spread of the corona virus extension of holiday & extension of restriction of movement.**

**Government has extended the Holiday/movement of people after May 5 under the following conditions;**

1. Government has extended the declared GENERAL HOLIDAYS till May 14. The holidays of May 6 Buddy Promina, The weekly holidays of May 08, 09, 15, & 16 will also added with this holiday order.
2. **Inter-district transport services will remain shut during this period. No one is allowed to move from one district/sub district to another. All People should stay home from 8:00 PM to 6:00 AM except emergency such as Medical & related services, etc.**
3. **All people should strictly follow the health guideline issued by Health Ministry.**
4. **Considering Eid & Ramadan, Shops will be allowed to remain open to do business on a limited scale. But all have to maintain distance and follow health guidelines during buying and selling. Big shopping malls will have to make arrangements for hand washing at their entrances and arrange disinfecting of vehicles entering the malls. All shops & Mall should close by 5:00 PM.**
5. Transport and employees of providing Emergency services such as Gas, Water, Electricity, Fire Service, cleaning service, Telephone and Internet Services, Port (Land, Water, Sea) Services, Power & Fuel, Postal services, etc will be out of this provision.
6. All kinds of road & water transports (Truck, Lorry, Cargo vessel, etc.) carrying goods will be continue.
7. This holiday will not be applicable for peoples engaged in Agro goods, food, fertilizer, Pesticide, industrial goods, kitchen market, medical goods, drug stores, hospitals and other emergency government services.
8. Movement of doctors, nurses, health workers and media persons, Transport of Medical equipments, press & media will be out of this provision.

9. Pharmaceutical sector, production units, export oriented industries & any industrial unit may remain open with ensuring safety of their workers and safety guide issued by Health Ministry if necessary.
10. Considering the situation, relevant other sectors of industries, Agriculture, Production, Supply chain & public transport will start later on.
11. No educational institution will be allowed to open during the period.
12. Banking services have also been provided considering Ramadan & upcoming Eid. Bangladesh Bank -- will give necessary directives in this regard.
13. If required ministries, related government Departments may remain open. They will issue required orders, in this regards.
14. None will be allowed to leave their workplaces during the Eid holidays. **Inter-district transport services will remain shut during this period.**

**The Prime Minister kindly give consensus of all the above instructions.**

The above instruction should follow immediately.
