Notice

Allocation of Business Among the Different Ministries and Divisions (Schedule 1 of The Rules of Business, 1996) (Revised up to April 2017), in the part of Public Administration with the power of rule 37, as continuation of the holidays declared Government has extended the declared GENERAL HOLIDAYS after May 16 under the following conditions:

1. **General Holiday declared from May 17 to May 28.** The holiday of 21st May (Sab-e-kadar), May 24 to 26 (Eid-UI-Fitar) & The weekly holidays of May 22,23, 29 & 30 will be also added with this holiday order.
2. All people & concern authority should strictly follow the health guideline issued by Health Ministry.
3. Transport and employees of providing Emergency services such as Gas, Water, Electricity, Fire Service, cleaning service, Telephone and Internet Services, Port (Land, Water, Sea) Services, Power & Fuel, Postal services, etc will be out of this provision.
4. All kinds of road & water transports (Truck, Lorry, Cargo vessel, etc.) carrying goods will be continued.
5. This holiday will not applicable for peoples engaged in Agro goods, food, fertilizer, Pesticide, industrial goods, kitchen market, medical goods, drug stores, hospitals and other emergency government services.
6. Movement of doctors, nurses, health workers and media persons, Transport of Medical equipments, press & media will be out of this provision.
7. Pharmaceutical sector, production units, export oriented industries & any industrial unit may remain open with ensuring safety of their workers and safety guide issued by Heath Ministry if necessary.
8. Considering the situation, relevant other sectors of industries, Agriculture, Production, Supply chain & public transport will start later on.
9. No educational institution will be allowed to open during the period.
10. Banking services have also been provided considering Ramadan & upcoming Eid. Bangladesh Bank -- will give necessary directives in this regard.
11. If required, Ministries and related government Departments may remain open. They will issue required orders, in this regards. All government officials should strictly follow the health guideline issued by Health Ministry.

12. None will be allowed to leave their workplaces during the Eid holidays.
