Subject: To limit the spread of the corona virus extension of restriction of movement/activities.

To limit the spread of the Corona Virus, Government has taking initiative to limit/restricting the movement of people & activities after May 30, 2020 under the following conditions:

1. This restriction will be effective from May 31 to June 15, 2020. The holidays of June 5, 6, 12 & 13 will be also included in this restriction order.
2. Inter-district movement of people will remain blocked during this period. No one is allowed to move from one district to another. Check post will remain present at entry and exit point of each District. Each District Commissioner with the support of law enforcement agency will enforce this restriction. People should remain stay at home during this period. All People should stay home from 8:00 PM to 6:00 AM except emergency such as purchase of necessary commodities, Medical & related services, **Going to Workplace**, graveyard for cemetery, etc. People should strictly follow the health safety measures including wearing masks at all times. Otherwise legal steps will be taken for violating this order.
3. All people should strictly follow the health guideline issued by Health ministry.
4. All have to maintain Social distance and other safety measures should be strictly followed during buying and selling at shops, markets and bazaar, etc. Shopping malls will have to make arrangements for hand washing/sanitizer at their entrances and arrange disinfecting of vehicles during entering the malls. All shops & Mall should close by 4:00 PM.
5. Transport and employees of providing Emergency services such as law enforcement agency, Gas, Water, Electricity, Fire Service, cleaning service, distribution of aid goods, Health services, Telephone and Internet Services, Port (Land, Water, Sea) Services, Power & Fuel, Postal services, etc will be out of this provision.
6. All kinds of road & water transports (Truck, Lorry, Cargo vessel, etc.) carrying goods will be continued.
7. This holiday will not applicable for peoples engaged in Agro goods, food, fertilizer, Pesticide, industrial goods, kitchen market, medical goods, drug stores, hospitals and other emergency government services.
8. Movement of doctors, nurses, health workers and media persons, Transport of Medical equipments, press & media will be out of this provision.

9. Pharmaceutical sector, production units, export oriented industries & any industrial unit may remain open with ensuring safety of their workers and safety guide issued by Health Ministry if necessary.
10. No educational institution will be allowed to open during the period, but can conduct online, distance courses.
11. **To provide full Banking services, Bangladesh Bank will give necessary directives in this regard.**
12. **All Public, Semi-Public, Autonomous, Private offices will remain open at their supervision in limited scale. Risky, Sick & Pregnant staff should not come to workplace. In this case all staffs should strictly follow the 13 steps health guideline issued by Health department. All meetings should conduct virtual/online except emergency situation.**
13. During this restriction period, none will be allowed to leave their workplaces. **Public transports, river transports and rail services will operate in limited scale with a predetermined amount of passengers while adhering to health and safety protocols. Concern ministry/department will issue separate instruction in this regard.**
14. **The aviation authority will also consider resuming flights under its management.**
15. During this period arrangement of all public meetings, public gathering and function will remain closed. Following safety measures mosques can arrange prayers. Other religious institutions can also conduct prayer.

Concern ministries/department should take necessary measures of the above instruction.
