- a) International passengers can get the test done at the selected hospital for Tk3,000 (maximum).
- b) No hospitals can be collaborated with any specific air agency to provide mandatory Covid-19 certificate.
- c) Each hospital should be very careful in collecting covid-19 sample, test and providing correct report.
- d) The results have to be reported to the “DHIS2 software” by the efficient operators so that immigration authority can avail the report of the passengers on time.
- e) Hospitals will verify the passports & flight tickets copy and collect sample. No samples will be collected 72 hours before the flight and the report has to be delivered at least 24 hours before departure.
- f) Hospitals should arrange individual set up at the lab premises with the proper hygiene for the passengers who will travel abroad.

- g) Hospitals should follow “IEDCR Quality Control” rules and pass the quality standard approved by DGHS.
- h) Authorized hospitals should open a HOTLINE number for 24hours for continuous support to the passengers who will go abroad.
- i) If RT-PCR report will be wrong/ incorrect, PCR test lab will have to take all the responsibilities.
- j) With the violation of above directions, DGHS is reserved rights to cancel the approval of RT-PCR lab.

All concerned authorities are requested to initiate the steps to check the passenger’s Covid-19 test certificate who will go abroad at country’s all land port, airport and river port.

  7. Square hospital, Panthapath, Dhaka
  8. Evercare Hospital, Bashundhora, Dhaka
  9. Prava Diagonistic, Banani, Dhaka
  10. United Hospital, Gulshan, Dhaka
- k) The international passengers can get the test done at the selected hospital for Tk3,000 (maximum)
- l) No PCR Test Lab can be enlisted to any air agency to provide mandatory Covid- 19 certificate.
- m) Each hospital should be very careful in collecting covid-19 sample, test and providing correct report to prevail image of BANGLESH in foreign land
- n) The results have to be reported to the DHIS2 software by the efficient operators as immigration authority can avail the report of the passengers on time.
- o) Hospitals will verify the passports & flight tickets copy and collect sample. No samples will be collected 72 hours before the flight and the report has to be delivered 24 hours before departure.
- p) Hospitals should arrange individual set up at the lab premises with the proper hygiene for the passengers who will travel abroad.
- q) Authorized hospitals should follow “IEDCR Quality Control” rules and pass the quality standard approved by DGHS.
- r) Authorized hospitals should open a HOTLINE number for 24hours for continuous support to the passengers who will go abroad.
- s) If RT-PCR report will wrong/ incorrect, PCR test lab will take all the responsibilities.
- t) With the violation of above directions, DGHS is reserved rights to cancel the approval of RT-PCR lab.

All concerned authorities are requested to allow the outbound passengers after checking the Covid 19 test certificate in country’s all land port, airport and river port.
