Subject: Extension of ongoing restrictions on activities and movement to prevent Covid-19 spread.

To prevent Covid-19 spread and to consider the present situation the ongoing PMO office issued directives announced earlier on April 12 & April 13, April 20 & April 23, 2021, will remain in force from midnight of April 28 till midnight of May 05,2021 with the same restrictions mentioned earlier, with the added instructions mentioned below:

- a) It is prohibited for any person from India to enter Bangladesh by land, sea or air (excluding transportation of goods. However, Bangladeshis who are now in India and whose visas have expired can enter Bangladesh on special consideration, taking permission from the Bangladesh High Commission in India. Concerned ministries and authorities will take necessary steps to strictly follow the rules and regulations made by the Department of Health regarding the 14-day quarantine of those entering Bangladesh.
- b) Shops and shopping malls will remain open from 10.00 am to 8.00 pm, maintaining health guidelines. Commerce and labor ministries and related business organizations and market management committees will take steps to ensure that the shops and shopping malls maintain health guidelines. Legal action will be taken against the rule-violators.
- c) The upcoming Eid-ul-Fitr prayers should be carried out in accordance with the instructions of the Ministry of Religious Affairs.
- d) Passengers coming from Middle East, Singapore, Malaysia and China with vaccination certificates and Covid-19 negative certificates will have to stay home for 14 days. But they will have to inform about their return and quarantine to the local police stations.
- e) Passengers returning from the above-mentioned countries, who only have Covid-19 negative certificates, will be in quarantine under government management. They will be

allowed to go home after 3-5 days and stay in 14-days home quarantine after doctors give permission. They must inform the respective police stations of their arrival.

f) And passengers from other countries are quarantined for 14 days at their own expense at government-designated hotels.

In this case, it is requested to take necessary action in the matter mentioned.
