To prevent Covid-19 spread and to consider the present situation, the ongoing PMO office issued directives announced earlier will remain in force **from midnight of 16th June till midnight of 15th July, 2021** with the conditions mentioned below:

- a. District Commissioners (DC) of highly effected areas can take additional measures to prevent infection of their own jurisdiction area with consultation of respective technical teams.
 - b. All government, semi-government, autonomous and private offices will be open in compliance with the health rules.
 - c. All tourist spots, resort, community centers & entertainment centers will remain closed.
 - d. Political, religious and social functions where public gatherings occurring such as marriage ceremonial functions, birthday party, picnic, party, etc., will remain closed.
 - e. Food Stores and Hotels - Restaurants will be able to sell / deliver food (Takeaway / Online) from 08:00 am to 10:00 pm and provide services to half the number of customers.
 - f. The concerned authorities shall ensure that all types of public transport carry half the capacity of passengers' subject to proper hygiene.
2. In this connection, government has requested to take necessary measures to relevant authorities.
