To prevent Covid-19 spread and to consider the present situation, the ongoing cabinet division issued directives announced earlier this restriction will remain in force from **06.00 AM of June 28**, **2021 till 6.00 AM of 1st of July, 2021** with the conditions mentioned below:

- a. All types of public transport will be closed during this period except Rikshaw and transport engaged in carrying commodities. Law enforcement agency will take necessary measures to implement the directive.
- b. All shopping malls, Tourist Spots, Market, Resorts, Community centers & recreation center will remain closed.
- c. Food shop, Hotel and restaurants may remain open from 8.00 AM to 8.00 PM. Only Takeaway/Online sell is allowed.
- d. All government private offices can open with required numbers of staffs, and should facilitate commute of their employees to work by using their own transport.
- e. Directives should be taken to wear mask and legal action need to be taken for anyone who do not comply the rule.

2. In this connection the authorities concerned requested to take necessary steps in this regard.
