Ministry of Commerce, exercising the authority conferred by Export and Import Law, Article 13 (B), hereby issues this notification.

**Notification designating the manufacturing year of imported automobiles for 2023**

1. Manufacturing year for Automobile import for 2023 is designated as follows:
  - (a) Passenger (*sedan/saloon*) vehicles – 2022 to 2023
  - (b) Business-use vehicles – 2019 to 2023  
(cargo/passenger)
  - (c) Fire engine / Ambulance – 2014 to 2023
  - (d) Machineries – 2014 to 2023
2. Regarding importation of the vehicles for above paragraph 1, sub-paragraph (a) to (c), only the left-hand drives would be permitted.
3. Regarding business-use machineries as per Appendix sheet that wouldn't be driven on public transport roads, those manufactured (15) years ago (2009 and later) would be permitted to import.
4. This notification is just issued as a normal action to annually designate automobile's manufacturing year by each calendar year according to procedures. We would like to announce that automobile's import-related policies wouldn't be altered, and it is practiced in continuation.
