Subject: Port restriction on import of certain goods from Bangladesh to India -Insertion of a new Para 19 under 'General Notes Regarding Import Policy' under ITC (HS), 2022 Schedule 1 (Import Policy)

S.O. (E). In exercise of powers conferred by Section 3 read with Section 5 of Foreign Trade (Development & Regulation) Act, 1992, read with paragraph 1.02 and 2.01 of the Foreign Trade Policy (FTP) 2023, as amended from time to time, the Central Government hereby introduces a new Para 19 to General Notes Regarding Import Policy under ITC (HS), 2022 Schedule 1 (Import Policy) with immediate effect.

"19. The import of following goods from Bangladesh to India shall be regulated as under:

Sl. No.	Item Description	Import Policy /Port restriction
(i)	All HS codes of Ready Made Garments (RMG)	Import from Bangladesh shall not be allowed from any land port, however, it is allowed only through Nhava Sheva and Kolkata seaports.
(ii)	Fruit/ Fruit flavoured and Carbonated Drinks	Imports from Bangladesh shall not be allowed through any
(iii)	Processed food items (Baked goods, Snacks, Chips and Confectionery)	LCSs/ICPs in Assam, Meghalaya, Tripura and
(iv)	Cotton and Cotton Yarn Waste.	Mizoram; and LCS
(v)	Plastic and PVC finished goods, except pigments, dyes, plasticisers and granules that form input for own industries.	Changrabandha and Fulbari, in West Bengal.
(vi)	Wooden Furniture	

1. Port Restrictions on import of Goods from Bangladesh

2. The above restrictions at Para 1 shall not apply to import of Fish, LPG, Edible Oil, and Crushed stone to India from Bangladesh

3. The above restrictions at Para 1 shall also not apply to Bangladesh exports to Nepal/Bhutan transiting through India."

Effect of the Notification:

A new Para 19 is introduced in 'General Notes Regarding Import Policy' under ITC (HS), 2022 Schedule 1 (Import Policy) regulating the Import of certain goods from Bangladesh to India, with immediate effect.

This is issued with the approval of Minister of Commerce & Industry.
